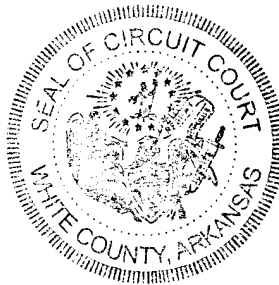
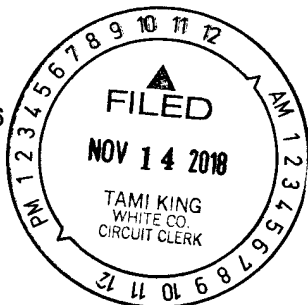

COMES NOW, **DETECTIVE KARA OSBORNE**, OF THE SEARCY POLICE DEPARTMENT AND AFTER BEING SWORN ON OATH STATES:

On August 16, 2018 I interviewed Zachary David Cox as a result of a juvenile female's disclosure of sexual assault allegations at the White County Child Safety Center.

During the interview, Zachary Cox stated he met the juvenile female in October 2017 during his employment with Searcy School District as a school bus driver. The juvenile female was a 15 (fifteen) year old student at Searcy High School, and was a passenger on the bus Zachary David Cox was assigned to drive.

They subsequently began a relationship that escalated into sexual contact.

He admitted to touching the juvenile female on her vagina, outside of her clothing, as well as placing his hand inside her pants and onto her bare buttocks.


He stated touching her aroused him sexually and as a result, gave him an erection.

He stated that he would hug her from behind and press his erect penis against her in an attempt to arouse her as well.

After being presented with additional allegations made in the juvenile female's interview of him providing nude photographs through text messages, he admitted to sending her several photographs of his penis.

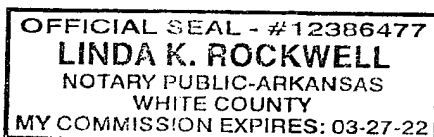
I, therefore, request warrants be issued for Zachary David Cox for Sexual Assault in the Second Degree/ ACA § 5-14-125(4)(A)(iii); a Class B Felony and Sexual Indecency With A Child/ ACA § 5-14-110(3)(C); a Class D Felony.
